PROGRAM OVERVIEW

APhA's Pharmacy-Based Immunization Delivery certificate training program is based on national educational standards for immunization training from the Centers for Disease Control and Prevention. This practice-based curriculum represents a fusion of science and clinical pharmacy. The program, which emphasizes a health care team approach, seeks to foster the implementation of interventions that will promote disease prevention and public health. The purpose of this certificate training program is to prepare pharmacists with comprehensive knowledge, skills, and resources necessary to provide immunization services to patients across the life span.

The registration fee for this program is \$400.

Following registration, participants will have access to course instructions, updates, presentations, webinar link, program evaluation, CE certificates and credits, etc. **This program is approved for 20 ACPE Contact Hours, 2 CEUs.** Once credit is awarded, transcripts will be available online within 24 hours on the learner's CPE Monitor profile at http://nabp.pharmacy/.

The Office of Alumni and Professional Affairs -Continuing Education strongly encourages each participant to check their profile online within 60 days of attendance to ensure credit has been awarded properly. ACPE will not accept CE submissions after 60 days from the live seminar date.

TARGET AUDIENCE

This knowledge-based program is intended for Pharmacists (ACPE).

LEARNING OBJECTIVES

- Educate pharmacists about the impact of vaccines on public health, pharmacists' role in immunization, immunologic principles of vaccine development and immunizations, vaccine-preventable diseases and the vaccines used to prevent them, strategies for improving immunization rates, and requirements for pharmacists who provide immunization services.
- Prepare pharmacists to read an immunization schedule and identify appropriate vaccines for individuals across the life span and with special needs, educate patients about the benefits of vaccines and dispel myths about vaccines, safely administer vaccines to patients via subcutaneous, intramuscular, intranasal, and intradermal routes, operate an immunization service in compliance with legal and regulatory standards, and partner with immunization stakeholders to promote immunizations and the immunization neighborhood.
- Direct pharmacists to resources necessary to promote public health through immunizations, access
 regularly updated information about vaccines and their use, effectively communicate with patients and
 other stakeholders about resources, and operate an immunization service in compliance with legal and
 regulatory standards.

PROGRAM FACULTY

Spencer H. Durham, Pharm.D., BCPS, BCIDP is an Associate Clinical Professor in the Department of Pharmacy Practice and also serves as the Director of Alumni & Professional Affairs with the Harrison School of Pharmacy. Originally from Arab, Alabama, he completed his pre-pharmacy coursework at Auburn University and graduated with his Doctor of Pharmacy degree from the Harrison School of Pharmacy in 2007. He went on to complete an ASHP-accredited post-graduate residency at Children's Health System in Birmingham, Alabama in 2008. After completion of his residency, he joined the staff at Sacred Heart Hospital in Pensacola, Florida as a clinical pharmacist specialist, a role he maintained for five years.

In 2013, Dr. Durham joined the faculty of the Harrison School of Pharmacy, where he teaches in various courses throughout the curriculum.

Additionally, Dr. Durham serves as the Director of Alumni and Professional Affairs under the Associate Dean for Clinical Affairs and Outreach. As part of this position, he works proactively with HSOP alumni and other health care professionals from throughout the state and region to foster the development of innovative practice models and to expand and enhance opportunities for continuous professional development.

Dr. Durham also oversees the Office of Alumni and Professional Affairs, which is responsible for the many continuing education programs offered each year by HSOP.

Dr. Durham has published more than 20 peer-reviewed articles in respected journals and several book chapters. He is an active speaker each year at national, state, and local conferences, where he educates healthcare professionals on topics related to infectious diseases and antimicrobial stewardship. Additionally, Dr. Durham is active in several state and national organizations including the Alabama Pharmacy Association (APA), the Alabama Society of Health-Systems Pharmacists (AlSHP), the American College of Clinical Pharmacy (ACCP), and the American Society of Consultant Pharmacists (ASCP).

Practice Site

Dr. Durham maintains a practice site at the Central Alabama Veterans Health Care System where he specializes in infectious diseases. He serves as a clinician in the inpatient acute care units, the long-term care facility, and the HIV and general infectious diseases outpatient clinics. At his practice site, Dr. Durham serves as a preceptor for both pharmacy students and residents. He also holds a dual board certification as a Board-Certified Pharmacotherapy Specialist (BCPS) and a Board-Certified Infectious Diseases Pharmacist (BCIDP).
