This webinar will offer information and tips to get started on implementing a depression screening service in pharmacies. Depression is a leading cause of disability in the world and pharmacists are in an ideal position to screen patients. This webinar gives advice and tips on overcoming barriers pharmacists face when implementing a depression screening service. The fee for this course is FREE.
